#### **Home Firearm Safety**

#### 4 hours

Home Firearm Safety is a non-shooting course that teaches students the basic knowledge, skills, and attitude necessary for the safe handling and storage of firearms and ammunition in the home. This is a 4-hour course for safe gun handling that is conducted in the classroom only. Students are taught NRA's three rules for safe gun handling; primary causes of firearms accidents; firearm parts; how to unload certain action types; ammunition components; cleaning; care; safe storage of firearms in the home; and the benefits of becoming an active participant in the shooting sports.

**Important Relevant Information: Transporting a Firearm in NJ** *FYI*: **Transporting a firearm in NJ between authorized places without a carry permit**: NJSA §2C:39-6.g – Exemptions: *Any weapon being transported* under paragraph (2) of subsection b., subsection e., or paragraph (1) or (3) of subsection f. of this section *shall be carried unloaded and contained in a closed and fastened case, gun box, securely tied package, or locked in the trunk of the automobile in which it is being transported*, and in the course of travel shall include only deviations *as are reasonably necessary under the circumstances*.

## NRA Handgun Training:

### **FIRST Steps Pistol Orientation**

#### 3 hours

Firearm Instruction, Responsibility, and Safety Training (FIRST) is the NRA's response to the American public's need for a handgun orientation program for new purchasers. FIRST Steps Pistol Orientation is designed to provide a hands-on introduction to the safe handling and proper orientation to one specific pistol action type. This course is 3 hours long and includes classroom and range time learning to shoot a specific pistol action type. Students will learn the NRA's rules for safe gun handling; the particular pistol model parts and operation; ammunition; shooting fundamentals; cleaning the pistol; and continued opportunities for skill development.

## **Basics of Pistol Shooting**

#### 8 hours

Basics of Pistol Shooting is intended for all individuals regardless of previous shooting experience and is delivered in the traditional classroom and range environment. This is an instructor-led 8-hour course where you will receive direct instruction from an NRA-certified instructor from beginning to end. Course topics include gun safety rules, proper operation of revolvers and semi-automatic pistols, ammunition knowledge and selection, pistol selection and storage, shooting fundamentals, pistol inspection and maintenance, marksmanship, and shooting range safety. Additionally, students will complete live fire training in a nationally standardized shooting qualification while on the range with an NRA Certified Instructor. #### **Defensive Pistol**

#### 8 hours

150 Rounds

Defensive Pistol teaches the knowledge, skills, and attitude to carry and use a concealed pistol ethically, responsibly, and with confidence. This course is 8 hours long and will focus on the techniques needed to develop a defensive mindset. Students should expect to shoot approximately 150 rounds of ammunition. As a result of participating in this course, the student will be able to explain and demonstrate the following: How to apply the NRA Rules for Safe Gun Handling when carrying a concealed firearm, basic principles of concealment, the difference between cover and concealment, drawing from the holster, levels of mental awareness, developing the proper mindset when using a pistol for personal protection, clearing common stoppages, use of pocket pistols, and more. This course is only conducted by NRA Certified Advanced Pistol Instructors. Please use a link on page 5 to register for this course.

#### **Basics of Personal Protection In The Home**

**150 Rounds** 

8 hours

Basics of Personal Protection in the Home teaches the basic knowledge, skills, and attitude essential to the safe and efficient use of a handgun for protection of self and family in the home, and to provide information on the law-abiding individual's right to self-defense. This is an 8-hour course. Students should expect to shoot approximately 150 rounds of ammunition. Students will learn basic defensive shooting skills, strategies for home safety and responding to a violent confrontation, firearms, and the law, how to choose a handgun for self-defense, and continued opportunities for skill development. Lesson III of this course: Firearms and the Law, and Legal Aspects of Self-Defense, is conducted by an instructor currently certified to instruct in this area of the law through the Retired Police Officers program and Security Officer Registration Act. Your instructor presents this module as an instructor so certified to do so, not as an NRA Instructor.

#### **Basics of Personal Protection Outside The Home**

14 hours

400 Rounds Basics of Personal Protection Outside the Home teaches students the knowledge, skills, and attitude essential for avoiding dangerous confrontations and for the safe, effective, and responsible use of a concealed pistol for self-defense outside the home. This course is for adult individuals who are not disqualified from possessing a firearm as defined by applicable federal and state laws and are of good repute and possess defensive pistol skills presented in the NRA Basics of Personal Protection In The Home Course. Participants must also understand the basic legal concepts relating to the use of firearms in self-defense and must know and observe not only general gun safety rules, but also those safety principles that are specific to defensive situations. Prospective participants can demonstrate that they have the requisite knowledge, skills, and attitudes by producing an NRA Basic Personal Protection In The Home Course Certificate, or by passing the pre-course evaluation. Part I is 9 hours and offers the essential knowledge and skills that must be mastered in order to carry, store, and use a firearm safely and effectively for personal protection outside the home. Students spend several hours on the range and shoot approximately 150 rounds of ammunition. Part II is an additional 5-hours on the range and another approximately 250 rounds of ammunition learning advanced shooting skills. Part III is Firearms and the Law and Legal Aspects of Self-Defense and is conducted by an instructor currently certified in this area of the law through the Retired Police Officers and Security Officers programs. Your instructor presents this module as an instructor so certified to do so, not as an NRA Instructor.

#### **Basic CCW (Carry a Concealed Weapon)**

16 hours

Carry a Concealed Weapons or CCW teaches the basic knowledge, skills, and attitude necessary to carry



a concealed pistol for personal defense. The CCW Course is intended for those individuals with previous shooting experience who can proficiently and safely handle a handgun. This instructor-led only course gives you direct instruction from an NRAcertified instructor from beginning to end and is conducted in a classroom and on a shooting range. This course may be completed in two single day formats or over several days with smaller blocks of instruction. Course topics may include Firearm Safety, Pistol Nomenclature and Selecting a Pistol for Self-Defense, Basic Defensive Pistol Skills, Drawing from Concealment, Loading and Stoppage Remediation,

Mindset, Carry Modes and Pistol Concealment, Firearm Cleaning, and Sport Shooting and Training Activities. Course length is determined by the modules the Instructor presents to meet your state's requirements for a permit to carry handguns. Additionally, students will complete live fire training on a nationally standardized shooting qualification while on the range with an NRA Certified Instructor. An instructor conducts Firearms and the Law and Legal Aspects of Self-Defense currently certified to instruct in this area of the law through the Retired Police Officers program and Security Officer Registration Act. Your CCW course instructor presents this module as an instructor so certified to do so, not as an NRA Instructor.

## **FIRST Steps Rifle Orientation**

Firearm Instruction, **R**esponsibility, and **S**afety Training (FIRST) is the NRA's response to the American public's need for a rifle orientation program for new purchasers. FIRST Steps Rifle is designed to provide a hands-on introduction to the safe handling and proper orientation to one specific rifle action type. This course is 3 hours long and includes classroom and range time learning to shoot a specific rifle action type. Students will learn the NRA's rules for safe gun handling; the particular rifle model parts and operation; ammunition; shooting fundamentals; cleaning the rifle; and continued opportunities for skill development.

## **Basic Rifle Shooting**

#### 14 hours

Basic Rifle Shooting teaches the basic knowledge, skills, and attitude necessary for the safe use of a rifle in target shooting. #### Retired Police (Law Enforcement) Officer or RPO 100 rounds 1 hour \$50



This is an initial and semiannual qualification only course which covers the N.J. Use of Force Training for Retired Law Enforcement Officers as a review, as well as semi-annual the Handgun Qualification Course 1 (60 rounds) and Handgun Night Qualification Course (40 rounds). This is not an educational **or instructional shooting course.** N.J. use of force statutes are reviewed as required then the state mandated courses of fire are conducted. Upon successful completion of the course, retired officers will be awarded the N.J. "Retired Law Enforcement Officer Firearms Training Record" to submit with their initial or biannual renewal applications or semi-annual pistol qualification. This course exceeds both the N.J. Retired Police (Law Enforcement) Officer Program requirements as well as the U.S. Law Enforcement Officers Safety Act (formerly H.R. 218) requirements and regulations.

## N.J. Permit to Carry Handguns (Initial & Biannual Renewal Applications)

for Private Citizens and Security Officers 2 hours 50 rounds \$200 This course is for initial & renewal applicants for a N.J. Permit to Carry Handguns.

N.J. Permit to Carry Handguns (Annual Re-qualifications) for Private Citizens and Security Officers \$100 1 hour 50 rounds This qualification course is for current N.J. Permit to Carry Handguns holders only.

These are qualification only courses which cover the N.J. Use of Force Interim Training for Private Citizen Concealed Carry and the Civilian Carry Assessment and Range Evaluation (CCARE) Protocol for both initial and renewal applicants. These are not educational or instructional shooting courses. N.J. use of force statutes are reviewed, then the state mandated course of fire is conducted. Upon successful completion of the course, students will be awarded the N.J. form S.P. 182 "Permit to Carry Safe Handling and Proficiency in the Use of Handguns Certification" and form S.P. 182a "Description of Additional Handguns Intended to be Carried" forms to satisfy the state requirements for a Permit to Carry a Handgun application.

**Important Relevant Information: Permits to Carry Handguns in NJ** 

FYI: Training and annual qualification on handguns intended to be carried. NJSA §2C:39-6.j. Exemptions. *A person shall qualify for an exemption* from the provisions of N.J.S.2C:39-5, as specified under subsections a. and c. of this section, *if the person has satisfactorily completed a firearms training* course approved by the Police Training Commission. The exempt person shall not possess or carry a firearm until the person has satisfactorily completed a firearms training course and shall annually qualify in the use of a revolver or similar weapon. ...

Stop the Bleed was developed by the American College of Surgeons to address preventable deaths from major blood loss (accidents, violent crime, active shooter events, etc.). This is a basic course and is suitable for all ages that can comprehend and follow basic tasks: It consists of 2 hours of lecture, demonstration, and hands-on modules using direct pressure, tourniquets, and packing of simulated wounds with gauze to stop major, life-threatening blood loss. The course objectives are: 1. The identification of major bleeding; 2. Use of pressure dressings to stop major bleeding; 3. Use of tourniquets to stop major bleeding on extremities; & 4. Use of wound packing to stop major bleeding in junctional areas (armpits / shoulders / groin area). This course follows the American College of Surgeons' guidelines and curriculum for the Stop the Bleed Program, and upon completion each participant will be issued a Stop the Bleed Certificate. This is a licensing course for persons desiring to become a security officer in N.J. Both the armed and unarmed (basic) courses begin with an initial 24-hour training period. The course of instruction will include the following general subject areas: 1. Homeland security and counter-terrorism; 2. Communications/emergency response; 3. Theft prevention; 4. Limits on the use of force; 5. Detention of suspects; 6. Ethics and professional conduct; 7. First aid/CPR/AED; and 8. Any other subject areas the Superintendent of State Police determines are necessary in the interest of public safety. Applicants will have to provide a copy of their Temporary Security Officer certificate and pass a 50-question written test based upon the required subject matter. Upon successful completion of the State Police application process and fingerprint background check, combined with this initial course completion, students will be licensed by the State Police to work in New Jersey as a Security Officer. *The armed security officer initial class does <u>NOT authorize or license or qualify anyone to carry a handgun – a Permit to Carry Handguns is still needed!</u>* 

#### Security Officer Registration Act or SORA

#### 8-hour refresher/renewal class \$100 tuition

This is a re-licensing course for persons desiring to continue being a security officer in New Jersey. Both the armed and unarmed (basic) courses require 8 hours of refresher training. Armed officers renew annually, unarmed (basic) officers renew bi-annually. The course of instruction will include the following general subject areas: 1. Homeland security and counter-terrorism; 2. Communications/emergency response; 3. Theft prevention; 4. Limits on the use of force; 5. Detention of suspects; 6. Ethics and professional conduct; 7. First aid/CPR/AED; and 8. Any other subject areas the Superintendent of State Police determines are necessary in the interest of public safety. Upon successful completion of the State Police renewal application process and background check, combined with the renewal course completion, students will be re-licensed by the State Police to continue work in New Jersey as a Security Officer. *The armed security officer renewal class does <u>NOT</u> authorize or license or <i>qualify anyone to carry a handgun – a Permit to Carry Handguns is still needed!* 

#### Important Relevant Information: Security Officers Carrying Handguns <u>FYI:</u> A Security Officer must have a Permit to Carry Handguns <u>or</u> RPO carry permit <u>AND</u> a SORA armed officer license to carry openly while in uniform unless falling under one of these statutory

**exemptions**: §2C:39-6 – Exemptions: a. Provided a person complies with the requirements of subsection j. of this section, N.J.S.2C:39-5 does not apply to: (c) An **airport security officer** or a ... (10) A **designated employee or designated licensed agent for a nuclear power plant** under license of the Nuclear Regulatory Commission, ... c. (5) A **guard employed by any railway express company, banking or building and loan or savings and loan institution** of this State, while in the actual performance of the guard's official duties; (15) A **person or employee of any person** who, pursuant to and as **required by a contract with a governmental entity, supervises or transports persons charged with or convicted of an offense**; ...

As a matter of information, the New Jersey State Police – Private Detective Unit, on behalf of the Superintendent of the State Police, is the regulating authority for the private security industry in NJ.

For the duration of the ANJRPC appeal in federal courts, gun owners **CANNOT** lawfully continue to carry in the following locations: Within 100 feet of a public gathering, demonstration, or event requiring a government permit; Zoo; Park, beach, recreational facility or area owned or controlled by a State, county or local government unit designated as a gun-free zone; Publicly owned or leased library or museum; Bar or restaurant where alcohol is served and any other site or facility where alcohol is sold for consumption on the premises; Entertainment facility; Casino and related facilities; Health care facility.

However, the carry-killer law is **STILL BLOCKED** for the following: Vehicles, Private property Public film locations.

Additionally, today's order does not disrupt the lower court's ruling on the following items which still remain blocked: Insurance requirements and Certain permit procedures and requirements.
