## NRA Safety:

### Home Firearm Safety

**4 hours**

Home Firearm Safety is a non-shooting course that teaches students the basic knowledge, skills, and attitude necessary for the safe handling and storage of firearms and ammunition in the home. This is a 4-hour course for safe gun handling that is conducted in the classroom only. Students are taught NRA's three rules for safe gun handling; primary causes of firearms accidents; firearm parts; how to unload certain action types; ammunition components; cleaning; care; safe storage of firearms in the home; and the benefits of becoming an active participant in the shooting sports. A firearm is not needed to attend this class. Please contact our Chief Instructor to schedule this course.

#### Important Relevant Information: Transporting a Firearm in NJ

**FYI: Transporting a firearm in NJ between authorized places without a carry permit:**

NJSA §2C:39-6.g – Exemptions: **Any weapon being transported** under paragraph (2) of subsection b., subsection e., or paragraph (1) or (3) of subsection f. of this section **shall be carried unloaded and contained in a closed and fastened case, gun box, securely tied package, or locked in the trunk of the automobile in which it is being transported, and in the course of travel shall include only deviations as are reasonably necessary under the circumstances.**

**Note:** *There is an Attorney General's Opinion covering "reasonable deviations".*

This course is 3 hours long and includes classroom and outdoor range time learning to shoot a specific pistol action type. Students will learn the NRA's rules for safe gun handling; the particular pistol model parts and operation; ammunition; shooting fundamentals; cleaning the pistol; and continued opportunities for skill development. A handgun and ammunition are required for this class. Please contact our Chief Instructor to schedule this course.

### Basics of Pistol Shooting

Basics of Pistol Shooting is intended for all individuals regardless of previous shooting experience and is delivered in the traditional classroom and outdoor range environment. This is an instructor-led 8-hour course where you will receive direct instruction from an NRA-certified instructor from beginning to end. Course topics include gun safety rules, proper operation of revolvers and semi-automatic pistols, ammunition knowledge and selection, pistol selection and storage, shooting fundamentals, pistol inspection and maintenance, marksmanship, and shooting range safety. Additionally, students will complete live fire training in a nationally standardized shooting qualification while on the outdoor range with an NRA Certified Instructor. A handgun and ammunition are required for this class. Please use a link on page 4 to register for this course.

## Defensive Pistol

**8 hours**

Defensive Pistol teaches the knowledge, skills, and attitude to carry and use a concealed pistol ethically, responsibly, and with confidence. This course is 8 hours long and will focus on the techniques needed to develop a defensive mindset in the classroom. Students should expect to shoot approximately 150 rounds of ammunition on the outdoor range. As a result of participating in this course, the student will be able to explain and demonstrate the following: How to apply the NRA Rules for Safe Gun Handling when carrying a concealed firearm, basic principles of concealment, the difference between cover and concealment, drawing from the holster, levels of mental awareness, developing the proper mindset when using a pistol for personal protection, clearing common stoppages, use of pocket pistols, and more. This course is only conducted by NRA Certified Advanced Pistol Instructors. A handgun and ammunition, plus other equipment are required for this class. Please use a link on page 4 to register for this course.

**NOTE: this course will qualify you for a New Jersey Concealed Carry Pistol permit application.**

## Basic CCW (Carry a Concealed Weapon)

**16 hours**

**250 Rounds**

Carry a Concealed Weapon or CCW teaches the basic knowledge, skills, and attitude necessary to carry a concealed pistol for personal defense. The CCW Course is intended for those individuals with previous shooting experience who can proficiently and safely handle a handgun. This instructor-led only course gives you direct instruction from an NRA-certified instructor from beginning to end and is conducted in a classroom and on a shooting range. This course may be completed in two single day formats or over several days with smaller blocks of instruction. Course topics may include Firearm Safety, Pistol Nomenclature and Selecting a Pistol for Self-

Defense, Basic Defensive Pistol Skills, Drawing from Concealment, Loading and Stoppage Remediation, Mindset, Carry Modes and Pistol Concealment, Firearm Cleaning, and Sport Shooting and Training Activities. Course length is determined by the modules the Instructor presents to meet your state's requirements for a permit to carry handguns. Additionally, students will complete live fire training on a nationally standardized shooting qualification while on the outdoor range with an NRA Certified Instructor. An instructor currently certified to instruct in this area of the law conducts Firearms and the Law and Legal Aspects of Self-Defense - our instructors are certified through the New Jersey Retired Police Officers qualification program and Security Officer Registration Act. Your CCW course instructor presents this module as an instructor so certified to do so, not as an NRA Instructor. A handgun and ammunition, plus other equipment are required for this class. Please contact our Chief Instructor to schedule this course. **NOTE: this course will qualify you for a New Jersey Concealed Carry Pistol permit application.**

FIRST Steps Rifle is designed to provide a hands-on introduction to the safe handling and proper orientation to one specific rifle action type. This course is 3 hours long and includes classroom and outdoor range time learning to shoot a specific rifle action type. Students will learn the NRA's rules for safe gun handling; the particular rifle model parts and operation; ammunition; shooting fundamentals; cleaning the rifle; and continued opportunities for skill development. A rifle and ammunition are required for this class. Please contact our Chief Instructor to schedule this course.

### **Basic Rifle Shooting**

**14 hours**

Basic Rifle Shooting teaches the basic knowledge, skills, and attitude necessary for the safe use of a rifle in target shooting. This course is 14 hours long and includes classroom and outdoor range time learning to shoot rifles. Students learn NRA's rules for safe gun handling; rifle parts and operation; ammunition; shooting fundamentals; range rules; shooting from the bench rest, prone, sitting, standing, and kneeling positions; cleaning, and continued opportunities for skill development. A rifle and ammunition are required for this class. Please contact our Chief Instructor to schedule this course.

### **FIRST Steps Shotgun Orientation**

Firearm Instruction, Responsibility, and Safety Training (FIRST) is the NRA's response to the American public's need for a shotgun orientation program for new purchasers. FIRST Steps Shotgun course is designed to provide a hands-on introduction to the safe handling and proper orientation to one specific shotgun model. This course is 3 hours long and includes classroom and outdoor-range time learning to shoot a specific model shotgun at a moving target. Students will learn the NRA's rules for safe gun handling; the particular shotgun model parts and operation; ammunition; shooting fundamentals; cleaning the shotgun; and continued opportunities for skill development. A shotgun and ammunition are required for this class. Please contact our Chief Instructor to schedule this course.

### **Basic Shotgun Shooting**

**10 hours**

**50 Rounds**

Basic Shotgun Shooting teaches the basic knowledge, skills, and attitude for the safe and proper use of a shotgun in shooting a moving target. This course is 10 hours long and includes classroom and outdoor range time learning how to shoot shotguns at moving targets. Students learn NRA's rules for safe gun handling; shotgun parts and operation; shotgun shell components; shotgun shell malfunctions; shooting fundamentals; range rules; shooting at straight away and angled targets; cleaning; and continued opportunities for skill development. A shotgun and ammunition are required for this class. Please contact our Chief Instructor to schedule this course.



## NJ Concealed Carry Permit:

### *for Private Citizens and Security Officers*



This course exceeds all the state requirements for:

- ◊ Initial Permit to Carry Applications
- ◊ Biannual Permit to Carry Renewal Applications
- ◊ Annual Handguns Qualification and Use of Force Refresher

**This is not an educational or instructional shooting course.** This course covers the N.J. Use of Force Interim Training for Private Citizen Concealed Carry and the Civilian Carry Assessment and Range Evaluation (CCARE) Protocol for both initial and renewal applicants as well as annual qualifications. The required N.J. use of force training is presented, then the N.J. mandated course of fire is conducted on an outdoor range. **Students must demonstrate safe firearms handling and proficiency in addition to a qualifying score to successfully complete the course.** Upon successful completion, students will be awarded the N.J. form S.P. 182 “Permit to Carry Safe Handling and Proficiency in the Use of Handguns Certification” and form S.P. 182a “Description of Additional Handguns Intended to be Carried” forms and other documentation necessary to satisfy the state requirements for a Permit to Carry a Handgun application. A handgun and ammunition, plus other equipment are required for this class. Please contact our Chief Instructor to schedule this course. *NOTE: this course will qualify you for a New Jersey Concealed Carry Pistol permit application.*

*NOTE: NJ State Police are now calling their permit to carry process **Concealed Carry Pistol (CCP).***

### **Important Relevant Information: Permits to Carry Handguns in NJ**

**FYI: Training and annual qualification on handguns intended to be carried.** NJSA §2C:39-6.j. Exemptions. **A person shall qualify for an exemption** from the provisions of N.J.S.2C:39-5, as specified under subsections a. and c. of this section, **if the person has satisfactorily completed a firearms training course approved by the Police Training Commission. The exempt person shall not possess or carry a firearm until the person has satisfactorily completed a firearms training course and shall annually qualify in the use of a revolver or similar weapon.**

*NOTE: NJSA§2C:58-4.6 lists prohibited areas/places where the carrying of a firearm is prohibited*

## NJ RPO & US LEOSA Carry Permits:

### **Retired Police {Law Enforcement} Officer or RPO**



**1 hour**

**100 rounds**

This course is restricted to retired law enforcement officers only and satisfies initial applications, biannual renewal applications, and semi-annual qualifications requirements. This course covers Handgun Qualification Course 1 (60 rounds) and Handgun Night Qualification Course (40 rounds). **This is NOT an educational or instructional shooting course.** N.J. Use of Force Training for the Retired Law Enforcement Officer is reviewed as required then the state mandated courses of fire are conducted. Upon successful completion of the course, retired officers will be awarded the N.J. “Retired Law Enforcement Officer Firearms Training Record” to submit with their initial or biannual renewal applications or semi-annual pistol qualification. This course exceeds both the N.J. Retired Police {Law Enforcement} Officer (RPO) Program requirements as well as the U.S. Law Enforcement Officers Safety Act (LEOSA - formerly H.R. 218) requirements and regulations. 
